GIST expands cooperation with Marine Energy Co., Ltd., for the development of new and renewable energy

- GIST (Gwangju Institute of Science and Technology) held a business agreement ceremony (MoU) and a donation ceremony on June 28 with Marine Energy Co., Ltd., (CEO Hyung-soon Kim) to foster skilled workers in the renewable energy sector and establish organic cooperation in related industries.
 - The signing ceremony was held at GIST with Acting GIST President Jong-In Song of GIST, CEO Hyung-soon Kim of Marine Energy Co. in attendance along with other key officials.
- The main contents of the agreement include: ▲ cooperation in training talented workers in renewable energy such as fuel cells ▲ promotion of industry-academic cooperation such as joint research and technical advice in renewable energy field ▲ field practice support to strengthen the practical skills of GIST students ▲ priority employment support for outstanding students ▲ support for customized practical training such as special lectures by experts from Marine Energy Co., Ltd. ▲ other areas requiring mutual cooperation were included.
 - Marine Energy Co., Ltd., has pledged 10 million won to the GIST Development Fund, with a cumulative donation of 130 million won.



- Acting GIST President Jong-In Song said, "In order to solve international problems such as global warming and fine dust, the establishment of new and renewable energy has become more important than ever, and a strategy for nurturing new industries in the future is essential. Through this agreement, we will actively cooperate so that GIST's excellent research capabilities and 30 years of field technology and know-how of Marine Energy Co., Ltd., can be harmonized."
