6 months and up to 2 years

This visa is for individuals who wish to engage in researching, technology / business start up activities in South Korea.

## Startup VISA / D-8-4

12 months and extended while doing your business

D-8-4 Technology and Business Startup visa issuance for founders of a corporation regarding technology and business startup immigration, who have bachelor's degree and intellectual property rights or equivalent skills.

## Trade VISA / D-9-1

12 months and extended while doing your business

A trade VISA is a specialization of trade in order to expand the convenience of staying in Korea for excellent foreign traders. The requirements for obtaining a trade visa are diversified by scoring experience in Korea.

# STARTUP VISA(D-8-4) / Corp.

## Requirements for Start-up VISA

Bachelor's degree or Associate's degree (only Korea)  
or Global Start-up Immigration Center Letter  
+ 80 points+ (at least one required item should be included)  
+ Corporation establishment

## Example of 80 Points

Basic Start-up Class (3 days, 25 points)  
+ Start-Up Coaching & Mentoring (10 hours, 15 Points)  
+ Corporation establishment (2 weeks, 15 Points)  
+ Basic Intellectual Property Course (2 days, 15 points)  
+ Patent or Utility (1 months, 20 points)

OASIS courses can be individually enrolled

### OASIS-2 : Advanced Intellectual Property Course (25 Points)

Advanced course necessary to acquire (apply for) intellectual property rights; required to stay in Korea

### OASIS-3 : Intellectual Property Application Support and Prototype Production Support

Select technologies (ideas) applied or registered with high commercialization possibility through public contests and support for commercialization and model production, one time per person.

### OASIS-6 : Invention, Start-Up Exhibition (25 Points)

Find opportunities to identify foreigner's creative intellectual property ideas and start-up items, open sales channels, and connect investors, etc.

### OASIS-7 : Graduation from Start-Up Incubation (15 Points)

Provide a stable start-up environment by giving a space to individuals who are prepared for a business start-up

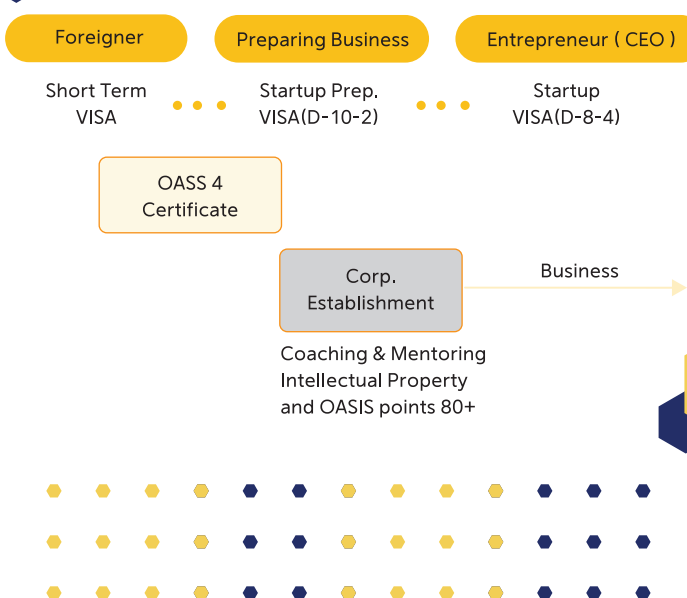
### OASIS-8 : Support for corporation establishment (15 Points)

Support the establishment of corporation, which is imperative to achieve a start-up VISA for successful start-up immigration

### OASIS-9 : Support Start-Up Items Commercialization (25 Points)

Promote successful start-up immigration with a policy support for start-ups at early stages

# Trade VISA(D-9-1) / Private Business

Korean Language Test TOPIK 3+ & 60 points+ out of 160 points, an applicant who has a required item point of 10 or more and has obtained a business (individual) registration certificate.

## Example of 60 Points

Basic Trading Course (OASIS4+) Certificate (3 days, 10 points)  
+ Korean College Degree (5 points)  
+ Korean Education Background (30 points)  
+ Period of stay in Korea 3+ years (15 points)
